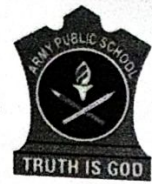

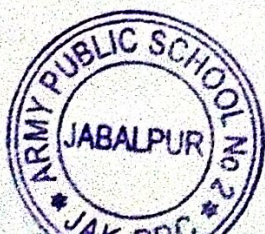
1. Sealed tenders are invited from experience and financially sound and reputed firms/supplier for execution of the following work at this school :-

5. **Execution of work.** The work will be executed within the stipulated period as specified in the supply order. Please note that contract can be cancelled unilaterally by the Buyer in case executed work is not found satisfactory and not carry out within the contracted delivery period. Extension of contracted delivery period/execution of work will be at the sole discretion of the Buyer, with applicability of LD clause.
6. **Inspection.** The work executed by the vendor will be inspected by a board of officers detailed by the Accepting Officer at the time of delivery of stores/completion of work and should be strictly according to the specifications provided in the supply order. In case the executed work is found not according to specifications/satisfaction of the Inspecting Officer, the same are liable to be rejected and will have to be replaced without any additional cost.
7. **Payment.** Full payment will be made on receipt of entire consignment in good condition by the consignee and on receipt bill. The rates are inclusive of all taxes and GST.
